Additional information that needs to be submitted with completed application:

Applicant must provide proof of sales tax permit issued by the state or proof that the goods sold are not subject to such sales tax.

Applicant must provide written proof of his/her authority to represent the company or individual he/she represents.

We will accept the following:

On company letterhead their supervisor/manager needs to write a short two sentence /statement that they authorize said person and his/her constituents to conduct business for the company.

Each applicant must provide a color photo of himself/herself, no larger than 1.5"x1.5"
